Sub:- Transfer Policy for Prasar Bharati employees-incumbency of officers
Of Prasar Bharati - regarding.

Respected Sir

This is with reference to Prasar Bharati Secretariat Letter No.A-10/40/2007-PPC dt.26.03.07 on the subject noted above.

Akashvani Doordarshan Administrative Staff Association is the sole representative body of LDC,UDC, Head Clerk/Accountant/Sr. Store Keeper, Administrative Officer, Senior Administrative Officer/Inspector of Accounts and Deputy Director Administration working in subordinate offices of All India Radio and Doordarshan. They are performing the rare functions in personnel and Financial Administration.

The transfer liability of Administrative Cadre i.e. from LDC to head Clerk/Accountant is restricted to within Zone and from Administrative officer onwards it is coming under all India transfer liability.

Recently DG,AIR has issued a Circular asking the details of stay of LDC to Head Clerk, which is not in the conformity of the circular issued by the Prasar Bharati Secretariat. As being a low paid employee normally these cadres are not coming under the transfer liability.

Further more the DG Doordarshan has recently proposes the transfer order of Administrative officer taking into the consideration of their tenure as Head Clerk also which is unfair. Head Clerk/Accountant & Sr. Store Keeper are coming under Group 'C' category therefore the tenure spent as HC/AC/Sr. S.K. may not be taken into consideration for counting the stay.

Time and again this association is requesting the CEO/DG/AIR/DGDD to extend the benefit of upgraded pay scale which has been extended to Engg. & Programme Cadre but it has not been extended so


far but in the transfer policy they have been equated with Programme & Enggs which is really unfortunate.

We therefore requesting you to intervene and Administer the Justice.

However on behalf of Association we assure you that on extension of benefit of upgraded pay scale the entire Administrative Cadre will accept the transfer policy whole heartedly.
